#### How does Locations On Demand work?

Within seconds multiple Nolym users near the requested location are pinged with a job alert. Once the job is accepted by a Nolym user or "Lensman" they have a short period of time to get on location and go live directly to you! But that's not all, Nolym has taken it a step further by allowing a Viewer to provide details of what they want to see on the Live View, plus communicate directly to the Lensman on scene. The video is saved in the Nolym app and can be downloaded to the mobile device that requested the job. All job requests are private between the Lensman and the Viewer. After the Live View is downloaded the Viewer has the option to upload the video to their profile if they choose to do so, or keep it private. After all, they paid for it.



#### What are the benefits of becoming an Early Adopter?

Those that download Nolym in the first ten (10) months are rewarded with a C Rating and higher profits per job than standard users. They also have the ability to transfer their account in the Up For Grabs Marketplace. C1-C5 Rated users can set their own prices on the Marketplace when listing their C Rated account "Up For Grabs". What is the Classification Protocol? <u>Classification Protocol (C1-C5 Rating</u>)




#### What makes a C1-C5 Rating valuable?

Account Transfers- Early adopters receive a classification rating and retain more profit per job as a Lensman. (See Diagram pg.5) A C1-C5 Rating also appears on the user's profile. This will be important later on as the "Transfer Account" feature is introduced after 18 months. Even if a user never goes live as a Lensman, they retain the ability to transfer their account rating to another user for a profit. Account Transfers are only available to those that are C Rated. After 18 months from the deployment of Nolym, a C Rated user may offer up for "Account Transfer" their C1-C5 Rating. The C1-C5 user sets a price of their own for the Account Transfer and submits it to the "Up For Grabs" Marketplace where other users can shop around and acquire the C Rating of the Assignor if a deal is made. After the transfer, more profit is generated on future jobs as a Lensman or by transferring the account rating to another user at a later date. Once a C Rated user transfers their account they become a standard user and must search the Marketplace if they ever want to acquire a better rate. A transaction on the Marketplace is called a "Popcornslide".

Example: A C1 sets the price for their account transfer at \$2,000. A *standard* user or any other C2-C5 Rated user seeking more profit per job can accept the account transfer for the price set by the Assignor. Once the parties complete the transaction and payment is received, the Assignor moves out of the C Rated category to the default rating (highest fee rate) essentially becoming a standard user. The other user acquires the C1 Rating with a lower fee rate retaining more profit per job. The new C Rated user now has the ability to transfer the account at a later time for an additional profit by listing it on the Up For Grabs Marketplace.

If any C2-C5 rated account acquires a better classification rating via the Up For Grabs Marketplace, their original C Rating is deleted from the system entirely.



# *Is there a limit to the supply of C Rated Accounts?*

There is no set number of C Rated Accounts.

#### Will C Rated Accounts appreciate in value?

There is no way to definitively determine the future outcome. However, it's likely as C Rated accounts start to get transferred by users after 18 months. Why? The amount of C2-C5 Rated accounts will lessen in supply as new and current users acquire better C Ratings. This could potentially drive up the market cost/value of the C Rated accounts in the "Up For Grabs" Marketplace as prices are always set by the users.

#### <u>Glossary</u>

#### Terms used in the Litepaper/Nolym Community

<u>Nolym</u> - Nolym has evolved into a symbol of the limitless potential of the human spirit. It represents the belief that anything is possible, and that with the right mindset and determination, people can achieve greatness and overcome even the most formidable obstacles.

Nolym is becoming a beacon of hope for people across the world, who yearn for a way to break free from the limits of their lives and embrace their full potential.

Lensman- A Lensman is a person providing a live streaming video to a requested Viewer. A Lensman can also be a free user that goes live in the main UI without fulfilling a job request.

<u>Viewer</u>- Any Nolym user that is watching live streaming content, whether it is a fulfillment of a job request or simply scrolling through live streams of Nolym users on the main UI.

<u>Classification Protocol (C1-C5)</u>- The Classification Protocol is a classification of users that downloaded Nolym in the first 10 months. A C1 User has downloaded in the first two (2) months. A C2 User has downloaded in the third (3rd) or fourth (4th) month etc. (see diagram pg.5).

C1-C5 Users are rewarded for their early adoption of Nolym by retaining more profit per job than a <u>standard User</u>. (One that downloads Nolym on or after day one of month eleven.) C1 Users make more profit per job than a C2 User and so on. A (C Rating) will appear on any early adopter's profile. C Rated Users can transfer their account by listing it on the Up For Grabs Marketplace after 18 months from the deployment of Nolym.

<u>Account Transfers</u>- Account Transfers are only available to those that are C Rated. After 18 months from the deployment of Nolym, a C Rated User may offer up for "Account Transfer" their C1-C5 Rating. The C1-C5 user sets a price of their own for the Account Transfer and submits it to the "Up For Grabs" Marketplace, where other Users can acquire the C Rating of the Assignor after the transfer, essentially making more profit on future jobs as a Lensman or later transferring the account rating for a profit.

<u>Locations On-Demand (LOD)</u>- A term coined by Veu Now LLC that identifies the process and technology used by the "Request A Live View" feature within Nolym.

<u>**Popcornslide-**</u> A Popcornslide is a nickname for the transaction between two users as they make a deal and complete an Account Transfer.

<u>"Up For Grabs" Marketplace</u>- A marketplace of C1-C5 Rated Users on Nolym interested in transferring their low fee rate account rating (C1-C5) for an agreed upon price to another Nolym user. (Available day 1 of month 18)
